

PLATTIN ROCK BOAT CLUB RULES AND REGULATIONS Revised November 11, 2004



1. FIREARMS: There shall be no firearms on the Boat Club property except as provided by city and state laws.
2. SPEED LIMIT: The speed limit on Club property shall be 15 mph.
3. PROFANITY: The Platin Rock Boat Club is a family-oriented organization. The use of language in a context or group that most reasonable people would find offensive or disturbing is not in keeping with the ideals of the Club and is hereby prohibited. (See Bylaws, Article IV, Section 8.)
4. LAUNCHING DOCKS: Except for those memberships that are directly related to the promotion of boating, such as boat merchants, launching facilities are to be reserved for the use of only members and their guests.
  - a) GUESTS' USE OF LAUNCHING FACILITIES: Other than the courtesy one-time only, free-use launch, Guests' and visitors' use of the Club's launching facilities is subject to the following:
    - Guests must be accompanied by at least one member in order to use the Club's launching facilities.
    - Guests' boats may be launched only if there is at least one Club member in attendance for each watercraft during the launching and/or taking out;
    - A member may bring more than one of his or her own watercraft, but a member and guest may not each bring his or her own watercraft.
    - Non-members found to be abusing these privileges shall be prosecuted as trespassing and shall be denied membership for a time period to be determined by the Club's Directors.
5. LAUNCHING ONLY: Launch docks shall be used only for the time required to launch or take out watercraft; other docks are provided for loading and unloading of boats.
6. NO WAKE ZONE: No wakes are allowed within 100 feet of all docks.
7. THEFT AND VANDALISM: Any misuse of Club property, including theft or vandalism, shall incur prosecution under appropriate city or state laws.
8. PARKING: All parking shall be orderly and as signs indicate.
9. TRASH: The cleanliness of the Club's grounds and shoreline is everyone's responsibility; members will be responsible for their guests' behavior.
10. CLUBHOUSE AND PAVILION USE: Members wishing to use the Clubhouse or pavilion for a group function shall contact the Commodore or Vice-Commodore for prior approval and reservation with the approximate number of people attending.
11. ANIMALS: Animals shall not be permitted in the Clubhouse.
12. ATVs: The use of ATVs shall be confined to roads and parking lots.
13. CAMPING: No-trace, primitive-only overnight camping is allowed.
14. WATERSKIING: Waterskiing shall be prohibited within 300 feet of all docks.
15. CHILDREN: Parents or guardians shall supervise their minor children at all times.
16. SWIMMING AND FISHING FROM DOCKS: Neither swimming nor fishing shall be permitted from docks.
17. CITY LAWS IN FORCE: While the Club property is private, Crystal City Laws do prevail.
18. LAUNCH RAMP/DOCKS: No boat shall be moored to the launching docks and left unattended at any time.
